SUBJECT: Fiscal Year 2010 Additional Funding Planning Instructions

1. **Purpose.** The purpose of this guidance is to provide those SCSEP grantees that were awarded FY 2010 Additional Funds with further instructions and procedures for the funds that became available on January 29, 2010. The period of performance is from January 29, 2010 through June 30, 2011, even though the statute makes funding available through December 31, 2011.
2. **References.** The following references may be used for additional information: 2006 Older Americans Act (OAA) Amendments, (Pub. L. 109-365,) 42 USC 3056 et. seq.; 20 CFR part 641; Training and Employment Guidance Letter (TEGL) 26-07; TEGL 30-07; TEGL 12-06; 20 CFR Part 1010, Priority of Service for Covered Persons; OMB No. 1205-0040; Training and Employment Guidance Letter (TEGL) 10-09; Department of Labor Appropriations Act (Pub. L 111-117, Division D); 2008 Americans with Disabilities Act (ADA) Amendments (P.L. 110-325); American Recovery and Reinvestment Act of 2009 (ARRA), (P.L. 111-05); Jobs for Veterans Act (JVA), (P.L. 107-288); January 29, 2010 Notice of Obligation Letter from SCSEP Grant Officer.
3. **Background.** The Department of Labor Appropriations Act, 2010, enacted by Congress and signed into law by President Obama on December 16, 2010, is intended to appropriate funds to the Department of Labor (DOL) for its FY 2010 activities. The Appropriations Act makes available an additional \$225 million to DOL for use by SCSEP to serve unemployed low-income older adults. The Appropriations Act overrides the formula that ordinarily guides allocation in Section 506 and the competition rules in Section 514 of the Older Americans Act. Except for specific provisions superseded by the Act, all existing rules and regulations for SCSEP apply. The Appropriations Act provides that the additional funding will be awarded to current grantees that "can effectively utilize additional funding." These funds are intended as a one-time addition to the current program as presently funded.

To identify grantees to receive SCSEP FY 2010 Additional Funds, ETA's Grant Office undertook a competition which invited all current grantees to submit a signed Statement of Intent that included a description of their demonstrated need, capacity to utilize funding, past performance and amount of funds requested. Successful grantees were notified on January 21, 2010, of their grant amount and provided instructions for submitting initial grant documents due to the Department on January 26, 2010. The submission included an Initial Statement of Work, SF-424 (OMB No. 4040-0004) and 424A (OMB No. 4040-0006) with preliminary budget narrative. This TEGL provides additional instructions, referenced in the Grant Officer's letter, to address in greater detail each grantee's plans for program implementation.

4. **Overall Approach.** The implementation of SCSEP FY 2010 additional funds should increase services and training for unemployed low-income older adults, as well as enhance community services. Grantees are expected to implement the Act expeditiously and effectively with full transparency and accountability. The grantees must describe the process used to determine the areas to be served with the additional funds. The grantees are also required to identify recruitment methods that will expand the number of participants and host agencies that possess the capability of providing participants with employment skill training necessary to secure employment opportunities. Grantees must also demonstrate the method they will use to manage spending and enrollments.
5. **Service to Participants.** Grantees are expected to use the SCSEP FY 2010 additional funding to enroll additional participants into their regular program. Grantees may also use these additional funds to ease the transition for participants funded by the Recovery Act who are not job ready and must transfer to the regular program. The transfer utility in the SCSEP Performance and Results Quarterly Progress Report (SPARQ) system will be used to effect these transfers. Grantees may serve participants in some or all of the areas in which they are currently authorized to operate. (See Attachment C.)
6. **Financial Reporting Requirements.** For the purposes of financial reporting, SCSEP FY 2010 additional funds are considered a separate grant and require submission of separate quarterly reports (9130s) (OMB No. 1205-0461).
7. **Performance Reporting Requirements.** For the purposes of program performance reporting, participants enrolled with SCSEP FY 2010 additional funds are considered enrolled in the regular program. Performance reporting for this additional money will be incorporated in the reports for the PY 2009 and PY 2010 regular grants. Grantees will not individually identify participants served by the additional grant money, and no additional reporting is required. The number of individuals served with the additional grant funding will be proportional to the amount of additional funding in each program year, i.e., the total number of positions calculated at \$13,743 for the full 17 months grant period.
8. **Grant Application Requirements.** As provided in the January 29, 2010 Notice of Obligation Letter and the initial grant award documents, the Department requires the items listed below to address full program implementation for the SCSEP FY 2010 Additional Funds. When completed and approved, the program narrative (as described in Attachment A) will serve as a Revised Statement of Work to replace the Initial Statement of Work currently contained in the Notice of Obligation.

Program Narrative (Attachment A). The program narrative must cover the following subject areas: description of decision-making process regarding which geographic areas will be served; recruitment of participants and host agencies; and method to manage spending and enrollments in multiple grants.

Authorized Positions (Attachment B). The grantee will reference Attachment B to determine the number of authorized positions to be served with this funding.

Geographic Areas to Be Served (Attachment C). The grantee must indicate the location of SCSEP authorized positions established in each jurisdiction with the FY 2010 Additional Funds by entering the number of slots per county onto the form provided as Attachment C. Refer to Attachment B for a list of grantees' authorized positions. Grantees may serve participants in some or all areas in which they are currently authorized. Completion of Attachment C fulfills the requirement in SF 424 to list geographic areas to be served.

Budget Information (Attachment D). Additional budget information, including a 424-A with detailed budget narrative, will be required in accordance with program strategies as outlined in the program narrative. The revised budget information will replace the budget and budget narrative initially supplied.

Programmatic Assurances (Attachment E). Grantees must submit signed programmatic assurances that reflect standard grant management requirements. These requirements are similar to those submitted with the PY 2009 grant application.

Optional Special Requests (Attachment F). Additional narratives, described in Attachment F, are required from any applicant with special requests in one or more of the following areas:

- Waiver for additional funds for training and supportive services;
- Administration cap limit changes;
- Reduction of maximum participant duration;
- Extension of maximum project duration;
- On-the-job experience (OJE) training option; and/or
- Cross-border agreements.

9. **Method of Submission.** Applicants must submit electronic copies of the items listed in Section 8 of this TEGL. The materials should be sent via e-mail to: **scsep.FY10addfund@dol.gov** and to their SCSEP Federal Project Officer (FPO) (Attachment G). If a grantee is unable to submit electronically, the grantee must submit hard copy applications via overnight delivery to the address below or by fax to 202-693-3817.

10. **Grant Application Intergovernmental Review.** The assurance of efficient intrastate coordination contained in Section 502(d) of the OAA 2006 Amendments is deemed to have been met by the PY 2009 grant application requirements. Because this additional funding is based on current PY 2009 authorized service areas, no changes in service areas will result.
11. **Schedule.** Grant materials meeting the requirements of this TEGl must be submitted in accordance with the requirements of Section 9 no later than May 14, 2010. However, applicants are encouraged to submit their materials as soon as possible.
12. **Action Requested.** Grantees with SCSEP FY 2010 Additional Funding must submit the additional materials required by this TEGl by May 14, 2010.

**PROGRAM NARRATIVE INSTRUCTIONS
FOR ADDITIONAL FUNDING**

Format: *The text of the application must be double-spaced with one-inch margins at the top, bottom, right, and left sides. Pages must be numbered with the grantee's name on each page. The Department permits the use of graphs, maps, and tables, but these must be properly labeled. The Department encourages applicants to use brief topic headings for paragraphs in the text. The narrative must not exceed 10 pages in length, excluding any attachments.*

Content: *The Department awarded additional funds to applicants based on overall need and capacity to spend funds immediately. All applicants that the Department awarded additional funding to must provide a narrative that covers the following areas:*

Description of Decision-Making Process: Selected applicants must indicate the number of SCSEP slots per county or city to be served with the new funds on the Distribution of Additional Funded Positions form provided in Attachment C. ***For the purposes of this narrative, applicants must:***

- a) Describe the decision-making process used to determine which counties or cities would be served and the number of slots delegated to each county or city with additional funding; and
- b) Describe the information that was gathered and the analysis that was used in making these determinations, particularly as it pertains to demonstrated need and capacity to spend funds immediately in the counties or cities chosen to receive funding.

Applicants are not required to serve in all cities or counties where currently authorized or to allocate funds according to an equitable distribution or formula.

Recruitment of Participants and Host Agencies: This additional funding represents a significant increase over and above regular PY 10 and Recovery Act funding. Meeting the enrollment goals for this program will require increased recruitment of participants and host agencies. ***Applicant must:***

- a) Identify specific recruitment strategies, along with a timeline, that will enable the applicant to recruit a sufficient number of participants to meet the enrollment objectives of this funding; and
- b) Identify specific recruitment strategies, along with a timeline, that will enable the applicant to recruit and retain a sufficient number of host agencies to assign the increased number of participants served by the FY 2010 Additional Funding.

Method and Tools to Manage Spending and Enrollments: Applicant must provide a description of how these additional funds and increased enrollments will be managed. *Specifically, applicant must:*

- a) Describe the information used internally to manage enrollments and expenditures in multiple SCSEP grants;
- b) Describe how this information is updated and analyzed to determine plans for enrollment levels and exits to ensure:
 - The least disruption to participants transitioning from Recovery Act before June 30, 2010;
 - The least disruption to participants enrolled with this funding at the close of the grant, on June 30, 2011; and
 - Effective and full use of funds during the grant period.

Assessment

Individual Employment Plan (IEP)

- Establishes an initial goal of unsubsidized employment for all participants.

Community Service Assignment (CSA)

Maintenance of Effort:

- Does not displace currently employed workers (including partial displacement, such as a reduction in non-overtime work, wages, or employment benefits).
- Does not impair existing contracts or result in the substitution of federal funds for other funds in connection with work that would otherwise be performed.
- Does not assign or continue to assign a participant to perform the same work or substantially the same work as that performed by an individual who is on layoff.

Orientation

Provides orientations for its participants and host agencies, including information on:

- Sub-recipients must also provide sufficient orientation, which may include the following information:

Participant Benefits

- Provides benefits that are required by state or federal law (such as workers' compensation or unemployment insurance) and the costs of physical examinations.
- Has established written policies relating to compensation for scheduled work hours during which grantee or sub-recipients are closed for federal holidays.
- Has established written policies relating to necessary sick leave that is not part of an accumulated sick leave program.

- Ensures that all financial reports are accurate and are submitted in a timely manner, as required.
- Has a written plan in place for both disaster response and recovery so the SCSEP may continue to operate and provide services.

Collaboration and Leveraged Resources

- Collaborates with other organizations to maximize opportunities for participants to obtain workforce development, education, and supportive services to help them move into unsubsidized employment. These organizations may include (but are not limited to): Workforce Investment Boards, One-Stop Career Centers, vocational rehabilitation providers, basic education and literacy providers, and community colleges.

Supportive Services

- Provides supportive services, as needed, to help participants participate in their community service assignment and to obtain and retain unsubsidized employment.
- Has established criteria to determine when participants will receive supportive services, including after obtaining unsubsidized employment.

Sub-Recipient Selection (If Applicable)

- In selecting sub-recipients in areas with a substantial population of individuals with barriers to employment, national grantees give special consideration to organizations (including former recipients of national grants) with demonstrated expertise in serving individuals with barriers to employment, as defined in the statute.

Complaint Resolution

- Establishes and uses written grievance procedures for complaint resolution for applicants, employees and participants.
- Provides applicants, employees, and participants with a copy of grievance procedures.

(1) **Additional Funds for Participant Training and Supportive Services, Older Americans Act Sec. 502(c)(6)(C).** Any applicant that wishes to request such additional funds must provide the specific information listed in this section. In addition, any applicant that requests these additional funds for participant training and supportive services should not submit a separate budget narrative for these activities. Instead, its application's detailed budget narrative should identify the specific training and supportive service activities that it intends to provide to participants if its request is accepted. Costs associated with this request should also be included in their SF 424 and 424A.

The 2006 Amendments permit an exception to the 75 percent minimum level of expenditures on participant wages and fringe benefits that allows grantees to request to use not less than 65 percent of program funds for wages, benefits, and other costs, so that up to an additional 10 percent of funds are available for training and supportive services for the direct benefit of participants. As required in Section 502(C)(6)(C)(IV), applicants interested in seeking this waiver must provide a work plan that includes the following:

- (a) A detailed description of the additional training and supportive services;
- (b) An explanation of how activities will directly benefit participants, improve project effectiveness, and improve employment outcomes for individuals served;
- (c) A sequence and timeline for these activities;
- (d) If applicable, an explanation concerning whether any displacement of eligible individuals or elimination of positions for such individuals will occur, and information on the number of such individuals to be displaced and of such positions to be eliminated; and
- (e) The performance measures that are expected to be improved by expenditure of additional funds and the amounts by which each measure is expected to improve.

(2) **Increase in Administrative Cost Limitations, 20 CFR 641.870.** The Department of Labor may authorize an increase in the amount available for administrative costs to not more than 15 percent if it determines that it is necessary to carry out the project, and the applicant demonstrates that:

- (a) It is incurring major administrative cost increases in necessary program components; or
- (b) The number of employment positions in the project or the number of eligible minority individuals participating in the project will decline if the amount available for paying the cost of administration is not increased; or
- (c) The size of the project is so small that the amount of administrative expenses incurred to carry out the project necessarily exceeds 13.5 percent of the amount for such project.

General statements that costs have increased do not constitute adequate justification. The applicant must identify which costs have increased, why they have increased, and how these costs relate to program operations.

(3) **Reduction of Maximum Participant Duration, OAA Sec. 518 (a)(3)(B)(i)**. The maximum length of time an individual participant can be enrolled in the SCSEP in the aggregate is 48 months (regardless of whether this participant is enrolled consecutively or not). If an applicant wishes to impose a maximum duration of *less than* 48 months for its program participants, it must request permission to do so from the Department in a separate attachment. Any such durational limit must be uniformly applied to all participants served by all of the applicant's local projects.

(4) **Extension of Maximum Project Duration, OAA Sec. 502 (b)(1)(C)(ii)**. The maximum average project duration based on overall participation is 27 months. If an applicant wishes to increase its maximum average project duration from 27 months to 36 months and have not already received permission to do so, it must request permission to extend its maximum average project duration to 36 months from the Department in a separate attachment.

(5) **On-the-Job Experience (OJE)**. If an applicant wants to utilize OJE as an additional training option, it must meet the requirements delineated in Older Worker Bulletin 04-04. The Department must approve the OJE policy and sample contracts before the grantee may exercise this option.

(6) **Cross-Border Agreements, 20 CFR 641.500(b)**. State applicants may enter into agreements to permit cross-border enrollment of eligible participants. Such agreements must cover both state and national grantee slots and must be submitted for approval by the Department.
