SUBJECT: Revised Minimum Disaster Unemployment Assistance (DUA) Weekly
Benefit Amount: January 1 – March 31, 2007

1. Purpose. To transmit a reissuance of the minimum weekly DUA amounts for all major disasters declared during the second quarter of fiscal year (FY) 2007. This issuance includes the AWBA for the State of Mississippi.
2. Average Weekly Benefit Amount (AWBA) Utilization. As required by 20 CFR 625.6, the attached list shows each state's AWBA used to determine minimum weekly DUA payments applicable for major disasters declared during the second quarter of FY 2007, from January 1 through March 31, 2007.
3. Action Required. State Workforce Agencies are requested to provide this information to appropriate staff and insure that the correct AWBA is used in determining the minimum weekly DUA amount.
